The Bid Security shall be in the form of certified check, cashier's check, or letter of credit pursuant to the Ohio Revised Code in the amount of 10 percent of the total bid; a Bid Guaranty and Contract Bond shall be in accordance with Chapter 153.571 of the Ohio Revised Code in the amount of 100 percent of the total bid.

Each successful bidder is required to furnish a Contract Bond in accordance with the Ohio Revised Code in the amount of 100 percent of the full contract sum, if not provided as part of the bid security. Attention of bidders is called to all of the requirements contained in this bid packet, particularly to the State of Ohio prevailing wage rates and various insurance requirements.

A prebid conference will be held at 10:00 a.m. on September 26, 2019, local time, at the Central Services Building Conference Room, 220 W. Livingston Street, Celina, Ohio 45822.
