Bids for the Broadway Street Improvements project will be received by the Mercer County Commissioners at the Central Service Building, 220 W. Livingston Street, Room A201, Celina, Ohio 45822, until Thursday, July 23, 2020 at 11:00 a.m. local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work: Reconstruction of Broadway Street from Wayne Street to First Street in the Village of Fort Recovery. The project construction will consist of replacing pavement, curb, curb ramps, sidewalk, and storm sewer as needed for the length of the project limits.

All official notifications, addenda, and other Bidding Documents will be offered through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office of Choice One.

The Contractor shall be required to pay not less than the minimum wage rates established by the Federal Labor Standards Provisions and Davis-Bacon Wages. Attention of the Bidder is called to the various insurance requirements and various equal opportunity provisions.

This project is funded through PY'19 CDBG Critical Infrastructure Funds.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.
