

MERCER SOIL AND WATER CONSERVATION DISTRICT ELECTION



The Ohio Soil and Water Conservation Commission will cause an election of Supervisors of the Mercer Soil and Water Conservation District (SWCD) to be held in accordance with Chapter 940 of the Ohio Revised Code. Individuals who own or occupy land within The Mercer Soil and Water Conservation District and are 18 years of age or older may vote for Supervisor.

There are 3 ways an eligible voter can cast a ballot:

1.) At the SWCD office from September 2, 2020 until September 15, 2020 during normal business hours (8:00 a.m. to 4:30 p.m.); or

2.) At the SWCD (Annual Meeting) Drive Thru, which will take place at the Mercer County Fairgrounds on September 15, 2020 from 5:30 p.m. to 7:00 p.m.;

or

3.) Voting absentee from August 3, 2020 until September 15, 2020 by requesting the ballot application and election ballot from the SWCD office at the following address 220 W. Livingston Street, Suite 1, Celina, OH 45822, by calling 419.586.3289 Ext. 3, or email karen.balster@mercercountyohio.org. Absentee ballots must be received by the SWCD office by 4:30 p.m. on September 15, 2020.

Two (2) Supervisors will be elected to a three-year term commencing January 1, 2021 and ending December 31, 2023.
