RESOLUTION #04-1136

WHEREAS, the Board of County Commissioners of Mercer County, Ohio have received a proposed amendment to the Mercer County Zoning Map as submitted by the County Rural Zoning Commission dated October 6, 2004; and,

WHEREAS, the Board of County Commissioners of Mercer County, Ohio conducted a public hearing on this 28th day of October, which was duly advertised in accordance with the Ohio Revised Code §303.12; and

WHEREAS, notification of hearing was given by first-class mail to all owners of property within, adjacent to or directly across the street from the area to be rezoned; and

WHEREAS, the Board has heard either in person or by counsel all evidence for and remonstrances against adopting the following amendment to the Mercer County Zoning Map as proposed by the County Rural Zoning Commission:

Re-classify the following parcel from SP Special/Parks to CL Commercial Light:

.90 acres, more or less, located in the northeast quarter of the northwest quarter of Section 3, East Jefferson Township, T6S, R3E. Said parcel is 7706 State Route 703 East, Celina and is owned by George Rafferty, Celina.

WHEREAS, the Board of County Commissioners of Mercer County, Ohio hereby finds that said proposed amendment to the Mercer County Zoning Map will be conducive to the public welfare. Now, therefore, be it
