Re-classify the following parcel from A-2 Agriculture District to CL Commercial Light District.

2.625 acres, more or less, located at the northwest corner of the intersection of Staeger Road and State Route 703E, Jefferson Township, Mercer County, Ohio. The property is owned by Linus Braun Trust, Celina, Ohio.
