REQUIREMENTS FOR LOCAL WORKFORCE DEVELOPMENT AREA POLICIES

Requires Separate Local Area Policy: means that the state policy specifically requires the local WDB to develop a policy for implementation in the local area.

May Use State Policy as Local Policy: means that the state policy does not specifically require an area-specific policy, however the WDB may adopt the state policy to ensure compliance in program implementation.

No Need for Local Policy: means that the state policy establishes the mandated processes for compliance.
