Being a parcel of land situated in the Northeast Quarter of  
Section Nine (9), Township Five (5) South, Range Three (3)  
East, Center Township, Mercer County, Ohio, and being more  
particularly described as follows:

Commencing at an iron pipe (found) at the Northwest corner of  
said Northeast Quarter; thence North 90° 00' 00" East Seven  
Hundred Thirty-three and One Hundredth (733.01) feet with the  
North line of said Northeast Quarter (centerline of Bogart  
Road), to a railroad spike (set) at the PLACE OF BEGINNING;  
thence continuing North 90° 00' 00" East One Hundred Fifty-five  
and Fifty-seven Hundredths (155.57) feet with said North line  
(centerline of Bogart Road), to a railroad spike (set); thence  
South 00° 00' 00" West Two Hundred Eighty (280.00) feet to an  
iron pipe (set); thence South 90° 00' 00" West One Hundred

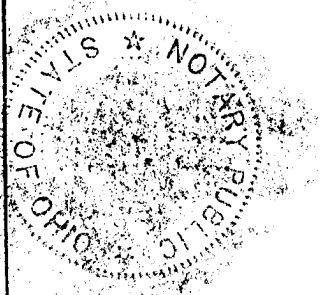
