particularly described as follows:

Beginning at an iron bar in the intersection of the centerline of  
U.S. Route 127 and Sites Road; thence with the half section line  
North Two Hundred Seventy-seven and Twenty-five Hundredths (277.25)  
feet to an iron bar; thence North 89° 30.1' East Two Hundred  
Thirty-two and Seventy Hundredths (232.70) feet to an iron bar  
passing an iron bar fifty (50) feet; thence South Two Hundred


