Commencing for reference at a mag-nail (found) at the southeast corner of the southeast quarter of Section 25 and the legal centerline of U.S. Route 127;

thence, N 01° 26' 40" E along the east line of Section 25 and the legal centerline of U.S. 127 for a distance of 1299.10 feet to a p-k nail (found) at the centerline intersection of U.S. Route 127 and State Route 219;
